## DESCRIPTION

The Green Barn, located on McClure Street in Lowell, is a square structure with a pyramid roof, topped by a square louvered cupola and encircled on three sides by a one-story lean-to. Wood shingles cover the pyramid roof. Corrugated sheet metal forms the roof of the low-pitched lean-to, which probably was originally covered with wood shingles. All exterior walls of the central square and the surrounding lean-to are sealed with vertical boarding.

No masonry foundations were used in the barn. Main vertical structural members have been planted in the earth. Inevitably the underground wood members have failed, resulting in serious settlement in all parts of the building, especially along the walls of the lean-to, some of which has collapsed entirely. Much of the sheetmetal roofing of the lean-to has disappeared.

## STATEMENT OF SIGNIFICANCE

Criterion: C Area of significance: Architecture

The Green Barn, built c. 1910, brought a structural system, a ground plan, and an overall silhouette to Benton County that is not familiar to this region. In spite of the obvious failure of much of the structural system, the new and interesting silhouette of the barn remains intact and is significant as a handsome but non-typical barn form in Benton County and in Arkansas.
