## DESCRIPTION

The Shady Grove School is a one-story rectangular frame building with a hipped roof. A double-leaf transomed door, flanked by six-over-six double-hung windows, forms the front facade. Each side elevation is penetrated by five pairs of four-over-four double-hung windows. A small gabled cupola sits on the central ridge of the hipped roof--a ventilator feature. A small brick chimney stands beside it. A continuous concrete foundation is visible around the perimeter of the building.

The Shady Grove School, built in c. 1922, is a twentieth century example of the community building tradition common in rural Arkansas since the mid-nineteenth century. Its traditional nineteenth century pattern was a two-story frame structure, generally built adjacent to a cemetery, serving the multiple function church, school, lodge hall (generally upstairs), and place for various civic and social assemblies. The Shady Grove Community Building is functionally similar and architecturally different only in its more modern and sophisticated architectural details, and is significant as an excellent representative of the educational architecture of its period.
